## Greetings Neighbors!

**Assessments:** We have had a few inquiries regarding annual assessments of \$125 per year and the \$50 fee for short term rentals. First, annual assessments were sent out in February and are due April 15. Our association has enjoyed complete continuity and has unbroken registration with the Secretary of State. Dues are still mandatory. Please note, as per our Covenants and Restrictions, unpaid dues can result in a lien. Second, a few years ago, the Board agreed to allow short term rentals with a caveat that each & every short term rental incurs a \$50 fee. This is not something the homeowner pays. It is to be borne by the renter. Anyone renting short term should list a \$50 rental fee on their Portal (eg AirB&B, VRBO, Homeaway) per booking. Those websites, however, will not send the collection to YHM. You must manually do that. Just as with annual assessments, short term rental properties not in compliance can be liened. Checks are to be mailed to: Yacht Harbor Manor Property Owners' Assoc., Inc. 1281 North Ocean Drive, #185, Singer Island, FL 33404.

**Street Signs:** Good News! We are progressing with our new upgraded street signs. I have sent a letter to the City confirming our intention to work with Giannetti to purchase signs to match those of Palm Beach Isles. Upon City approval, the manufacture and shipping will take about 22 days.
